I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed IDIQ Contract to a qualified legal firm to provide support for drafting legislation services in accordance with Scope of Work.
- B. The contract will be for a one-year period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. **PROCEDURES.**
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of **\$100**. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed **\$150,000**. This reflects the contract maximum for this period of performance.”

THE U.S. DEPARTMENT OF STATE (DOS), U.S. Embassy in Tashkent is seeking high quality domestic or international law firm experienced in capital markets law and regulations and/or legislative drafting to provide the U.S. Government technical expertise in a services project.

In carrying out its commitment to support Uzbekistan in developing its capital markets, an important USG policy priority and a benefit to the U.S. Government, the U.S. Embassy in Tashkent seeks to commission a qualified legal firm to provide support for drafting legislation that will lay the groundwork for ongoing and future reforms in the capital markets.

The following services are required by the United States Government (USG) in relation to the legislative drafting technical services project:

DESCRIPTION

The USG is seeking legal services in connection with:

- Technical services provided to the U.S. Embassy in Tashkent to prepare new draft laws based on model provisions provided by the U.S. Department of Commerce’s Commercial Law Development Program (CLDP).

The selected firm must be able to demonstrate high level proficient English-language capabilities.

STATEMENT OF WORK

1. Background

a. In October 2019, the President of the Republic of Uzbekistan directed Capital Markets Development Agency (the “CMDA”) and the Uzbekistan Ministry of Justice to prepare new draft laws (1) on the Regulator; and (2) On the Capital Markets (the “Draft Laws”) and to consolidate all relevant laws, acts, and decrees into a single, simple, and flexible capital markets code (the “Capital Markets legislative reform project”).

b. In February 2020, then-U.S. Secretary of State Pompeo announced that the U.S. Government was allocating \$1 million to support CMDA , including though the acquisition of legal services,

in its assigned task of updating and reforming Uzbekistan's laws regarding the capital markets regulator and the capital markets. The U.S. Department of Commerce's Commercial Law Development Program (CLDP) has been chosen to lead the Capital Markets legislative reform project within the U.S. government, but has no formal presence in Uzbekistan.

c. CLDP will apply funding allocated from the Department of State to award an Indefinite Delivery/Indefinite Quantity (IDIQ) Contract and pay a Tashkent-based, English-language capable law firm that will carry out legal drafting of the Draft Laws.

d. To contract with the law firm, the U.S. Embassy in Tashkent will enter into a contract with a law firm, (the "Contractor"). The Contractor will organize a Drafting Team of lawyers to perform the duties detailed in the following paragraphs. In the performance of these duties, the Contractor will report to a Contracting Officers Representative (COR) to be identified at the U.S. Embassy in Tashkent and to CLDP's Program Manager for Central Asia, at the frequency described below.

e. The contract will be for one year, with deliverables due in the first three months, per the timetable set forth in Section 3.

2. Legal Services Related to the Draft Laws

a. CLDP has assembled an Advisors' Group to identify model securities laws and provisions and/or checklists of key elements of successful securities laws regimes which capture international best practices in the area of capital markets regulations and which foreign investors will expect to see in Uzbekistan's Draft Laws.

b. After receiving input from the Advisors' Group, CLDP will provide CMDA the model laws and provisions and/or checklists of key elements identified by the Advisors' Group.

c. CMDA will determine which model laws, provisions, and/or key elements must be included in the Draft Laws and will provide those to CLDP for translation into Russian and transmission, in English and Russian, and on a rolling basis, to the Drafting Team.

d. Based on the model laws, provisions, or key elements received, the Drafting Team will prepare the Draft Laws as cohesive statutes, including sections or individual provisions provided by CMDA, and circulate through CLDP the drafted Laws, sections, or provisions to CMDA and to the Advisors' Group for review and comment.

e. The Drafting Team will work to ensure that the Draft Laws, sections, or provisions are in compliance with the Constitution of the Republic of Uzbekistan and in keeping with legislation drafting practice in Uzbekistan.

f. The Drafting Team will draft in Russian.

g. Relying on an inventory of the current laws and regulations prepared by CMDA in Uzbekistan regarding the capital markets and related topics, (the Перечень действующих НПА в Республике Узбекистана о рынке капитала/Inventory of Current Capital Market Laws and Regulations in the Republic of Uzbekistan, hereinafter the "Перечень/Inventory"), the Drafting Team will identify and list the laws, regulations, and provisions currently in force in the Republic of Uzbekistan (the "List of Identified Current Laws,") the subject of which the Draft Laws will cover and which the Draft Laws will potentially supersede.

h. The Drafting Team will provide the completed Draft Laws, sections, or provisions, as well as the List of Identified Current Laws to CLDP for distribution to CMDA and for translation into English for distribution to the Advisors' Group, for review and comment, including sections or individual provisions as they are completed.

i. The Advisors' Group, through CLDP, will provide its comments on the Draft Laws, sections or provisions and the List of Identified Current Laws to CMDA.

j. CMDA will determine which comments to incorporate into the finalized Draft Laws, and will analyze and edit, as necessary, the List of Identified Current Laws and will provide those selected comments and the edited List of Identified Current Laws to CLDP to provide to the Drafting Team. CLDP will provide the selected comments and the edit List of Identified Current Laws to the Drafting Team in English and in Russian.

k. The Drafting Team will finalize the Draft Laws by incorporating the comments CMDA has selected for inclusion in the finalized Draft Laws and by incorporating notations regarding the edited List of Identified Current Laws (the “Finalized Draft Laws”) and will provide the Finalized Draft Laws, including sections or individual provisions to CLDP.

l. CMDA, the Drafting Team, CLDP, and the Advisors’ Group will repeat any of the above-described processes required to assist the Drafting Team and CMDA to finalize the Draft Laws;

m. CLDP will submit a complete and final copy of the Finalized Draft Laws to the U.S. Embassy Tashkent.

4. Reporting and Billing

a. While completing the tasks set forth in paragraphs 1.a-x above, the Contractor will report on a weekly basis to the COR and to CLDP (the “Report”) and will be available for weekly meetings or videoconferences with the COR and with CLDP.

b. The Report will include a written update regarding the progress of completing the Draft Laws in a format to be agreed with the COR and CLDP upon commencement of work.

c. When making the weekly Report, the Contractor will also provide the COR and CLDP with any sections, provisions, or Draft Laws completed that week.

d. Every two weeks, the Contractor will provide an invoice detailing the hours spent on the Capital Markets legislative reform project by the Drafting Team during the previous two weeks. These invoices will use a format to be agreed with the COR and CLDP upon commencement of work.

5. QUALIFICATION REQUIREMENTS

Requirement 1: Contractor must provide documented proof that it has been in operation as an ongoing business (law firm, law office, or attorney operating as a sole proprietor) for at least 3 years.

Requirement 2: Contractor must provide documented proof that it has previous specific experience in matters of securities laws and/or capital markets generally and/or in legislative drafting in the Republic of Uzbekistan specifically.

Requirement 3: Contractor must provide documented proof that all the employees/subcontractors who will be part of the team to be assembled by Contractor, if awarded a contract under the present solicitation, have the following attributes:

A. Each is licensed to practice law and/or are otherwise qualified to draft legislation in the Republic of Uzbekistan.

B. Collectively, the employees/subcontractors have sufficient proficiency in the English language to prepare the Draft Laws in English.

Requirement 4: Contractor must provide documented proof that the team to be assembled by the contractor, if awarded a contract under the present solicitation, will be led by a Senior Lawyer, and that this Senior Lawyer has specific experience in matters of securities laws and/or capital markets generally and/or in legislative drafting, in the Republic of Uzbekistan, specifically.

While not a requirement, a preference will be given, among several offerors, to the one whose proposed team members have the most significant record of demonstrated experience, legal scholarly work, legal publications, or legal teaching, in matters related to securities law and/or security markets in Uzbekistan or abroad.

Requirement 5: Contractor must be located in Tashkent or have sufficient presence in Tashkent to allow for meetings with CLDP and/or U.S. Embassy personnel at the reasonable discretion of CLDP and/or the U.S. Embassy.

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue

Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying. In the absence of a completed IRS Form W-14 accompanying a payment request, the default withholding percentage is 2 percent for the section 5000C withholding for that payment request. (a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from date of award through base period or option periods if exercised. See F.2.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14.
